

# Additional Money-Earning Application for Troops

Certain money-earning activities outside of council-sponsored product sales require approval. Use this form when your troop:

- ▶ Conducts an activity where the purpose of the event is to raise funds for the troop treasury, and funds are collected from outside the troop members (i.e., registration fees, sales)
- ▶ Holds an event that does not provide a programmatic activity for Girl Scouts but that raises funds for the troop treasury

Prior to submitting this application to the Senior Troop Finance Liaison, please review the Volunteer Essentials section on “Money Earning” and Safety Activity Checkpoints. # Additional Money-Earning Guidelines for Troops

## Guidelines

For more information about Girl Scouts – Diamonds Council's Money-Earning Guidelines and Policies, please consult Volunteer Essentials, Troop Finances. Girl Scout troops are financed by dues, money-earning activities, community support, and a portion of the proceeds earned through council product sales. "Council product sales" are council-wide sales of authorized products, such as Girl Scout Cookies, magazines, nuts or candy in which membership pathways participate. A "money-earning activity" refers to any activity that generates revenue for the troop treasury that is not dues, council product sales, and/or donations; "fundraisers" are included as a form of money-earning activity and are covered in the following guidelines and application. Money-earning activities should always follow a planned budget and be carried out by girls and adults, in partnership. **Girl Scout funds are for Girl Scout activities and are not to be retained by any individual or individuals as their own.**

The Girl Scout Cookie Program and Fall Product Program are both designed to help girls develop key financial literacy skills, as well as provide an opportunity for troops to generate their own funds to support their Girl Scout activities.

At times, some troops may find that their girl-led plans may exceed their revenue from the product program sales; with approval, Girl Scout troops may participate in additional money-earning activities to supplement their budgets. Troops must review the following money-earning guidelines and submit the application to receive approval to conduct a money-earning activity when the following conditions apply:

- ▶ Conducts an activity where the purpose of the event is to raise funds for the troop treasury, and funds are collected from outside the troop members (i.e., registration fees, sales)
- ▶ Holds an event that does not provide a programmatic activity for Girl Scouts but that raises funds for the troop treasury

Before holding the troop's money-earning activity, troops should submit the Money-Earning Application. **Applications will be reviewed, and the troop contact will be notified by email or phone of the status of the application within five (5) business days of receipt of the request.**

- ▶ Troops must submit the Troop Money-Earning Activity Application for approval to the Senior Troop Finance Liaison at least three (3) weeks prior to the activity. - ▶ Troops must submit the activity budget with the completed form.
- ▶ Troops must submit a copy of its latest bank statement with the completed form.
- ▶ Troops must be active participants in the council product sales and be in financial and membership good standing (no debt, actively registered troop meeting adult volunteer minimal).

**Girls’ participation in troop money-earning projects or council product sales activities is based upon the following:**

- ▶ Voluntary participation
- ▶ Council guidelines and policies
- ▶ An understanding of, and ability to interpret to others, why the funds are needed
- ▶ The ability to follow correct business procedures
- ▶ Observance of local ordinances related to involvement of children in money-earning activities, as well as, meeting health and safety laws.
- ▶ Adherence to policies and procedures found in Volunteer Essentials and Safety Activity Checkpoints.
- ▶ Planned arrangements for safeguarding the money.

Money-earning activities, like all Girl Scout activities, should include the 3 Girl Scout Processes: Girl-Led, Learning-by-Doing, and Cooperative Learning. Allow girls to take the lead with the planning by brainstorming and developing their own ideas, help girls to understand their troop finances better through their hands-on budgeting and implementation, and encourage lively participation by all girls. Have the girls plan all details of the event and be sure to review Volunteer Essentials and Safety Activity Checkpoints.

**Troop Money-Earning Activities by Level**

Additional money-earning activities should be used to raise money to support Girl Scout activities, not take the place of Girl Scout activities and must be age- and programmatically-appropriate. Girl Scout troops may participate in a certain number of additional money-earning activities by level:

Daisies	Brownies	Juniors	Cadettes, Senior and Ambassadors	Multi-Level Troops
Daisies may NOT participate in additional money-earning activities	AFTER participation in both product sales, Brownies may participate in 1 additional money-earning activity with approval	AFTER participation in both product sales, Juniors may participate in 2 additional money-earning activities with approval	AFTER participation in both product sales, Cadette, Senior and Ambassador troops may participate in 2 additional money-earning activities with approval; if troop is planning a trip, 1 additional money-earning activity can be held; troops earning their Silver and Gold Awards can also apply for 1 additional money-earning activity PER PROJECT	Mixed level troops may conduct a maximum number of money-earning activities in accordance with the highest level registered in the troop, and the girls in the troop may only participate to their appropriate level.

**Allowable Money-Earning Activities**

Troops should focus on activities that promote learning and/or service opportunities for girls and that complement the Girl Scout Leadership Experience. Some examples of approved money-earning activities include, but are not limited to:

- ▶ Providing a service: babysitting, dog walking, gift wrapping, recycling projects, etc.
- ▶ Making and selling items (not resale): crafts, art work, (garage sales are allowed)
- ▶ Hosting an event: providing meals or dances for families

Girl Scouts, in their Girl Scout capacity, may not sell commercial products outside of the council product sales. Anything sold at retail is a commercial product. Girls may not sell commercial products as money-earning activities. This includes, but is not limited to, items such as candles, soaps and fireworks. Product in-home “parties” where items (i.e., jewelry, clothing, make up, purses, etc.) are sold directly to consumers are not approved money-earning activities – even if a portion of proceeds are donated to Girl Scouts. Troops may not engage in crowdfunding.

### Troop Money-Earning Activity Budget Sample

A completed budget must be submitted with all additional money-earning applications that show an understanding of what money is being raised for and a thorough identification of all revenue and expense items (even if items are donated or provided by other sources, like troop families). A sample budget for a Themed Dinner is below:

### Special Money-Earning Activity for the Juliette Low World Friendship Fund

Girl Scout service units and troops may conduct a special money-earning activity to promote philanthropy, raise awareness, and funds for the Juliette Low World Friendship Fund (JLWFF). This special money-earning activity should follow the Money-Earning Activity Policies outlined above. Events and activities such as this may be held annually and should be included in the service unit planning and budgeting process. Special money-earning activities should be done only for the JLWFF and should not be held in conjunction with other money-earning activities.

### Additional Guidelines for Money-Earning Activities

Additional money-earning activities should not compete with council-sponsored product programs; for specific dates, please contact the Senior Troop Finance Liaison.

### Girl Scout Service Units and Troops and Grants and United Way Applications

Girl Scout service units and troops may not solicit grants from foundations or corporations. Girl Scout service units and troops may not solicit funds from United Way or United Fund organizations.

### Avoid Fundraising for Other Organizations

Girl Scouts are not allowed, when acting in a Girl Scout capacity (such as wearing a uniform, sash or vest, official pins, etc.) to solicit money on behalf of another organization. This includes, but is not limited to, participating in a walkathon or telethon while in uniform. The service unit or troop can support another organization through Take Action Projects or by making a donation from the service unit or troop bank account. In addition, Girl Scouts as individuals are able to participate in whatever events they choose, so long as they are not wearing anything that officially identifies them as Girl Scouts.

Girl Scouts, in their Girl Scout capacity, may participate in certain events for other organizations if there is an active partnership with the council. Girl members who do this should not solicit or accept pledges, donations or sponsorships for their participation. Please contact the Senior Troop Finance Liaison to inquire about the partnership.

### Avoid Political Fundraisers

Girl Scouts, in their Girl Scout capacity, may not participate (directly or indirectly) in any political campaign or work on behalf of or in opposition to a candidate for public office. Letter writing campaigns are not allowed, nor is participating in a political rally, circulating a petition, or carrying a political banner.

# Troop and Service Unit Money-Earning Activity FAQ

We understand that our Girl Scouts have big dreams! And some of these big dreams have big price tags. Here are some ways that your troop or service unit can raise additional funds, while still staying within our GSUSA Blue Book of Documents and council policies and guidelines. Good luck out there!

## Let's Get Started...

- ▶ Check Volunteer Essentials, Troop Finances section on Additional Money-Earning and *Safety Activity Checkpoints*.
- ▶ Review the “Additional Money-Earning Activity Guidelines and Application” found on the website.
- ▶ Let the girls take charge! Like all things GSLE, money-earning should also be girl-led. Have girls lead the discussion, planning, even execution (as is age appropriate).

**Here are some suggestions to help your troop or service unit get moving in the right direction:**

*Yay!*

**Host an Event!** Providing a meal (themed dinners are a wonderful way to charge a higher ticket price!) or other fun activity to reach out to non-Girl Scouts is a fantastic way to earn funds.

**Provide a Service!** Offering babysitting services at holiday times or service unit/Girl Scout events, dog walking, badge/patch ironing before bridging, or fun “services,” like Flamingo Flock Removal, are all great ways to do a good turn while earning funds.

**Get Crafty!** And Entrepreneurial! Making and selling your troop's artwork or craft creations is an excellent way to generate funds through your hands-on work and allows girls another opportunity to grow their business skills. (Garage sales are allowed.)

**Think Outside the Box!** Be an innovator and dream up new ideas to support your Girl Scout activities.

*Nay!*

**No selling or reselling of commercial products.** This includes in-home product demonstration parties, even if a portion of the sales is donated back to Girl Scouts. If parents or other adults wish to host a product party with a donation opportunity, the event must not imply any endorsement or partnership with Girl Scouts, and no girls in their official Girl Scout capacity may be present.

**No fundraising for other organizations.** Girl Scouts are not allowed, when acting in their official capacity, to solicit or accept money on behalf of other organizations (for-profit or non-profit).

**No online crowdfunding.** If a donor wishes to make an online donation to a troop, they can use our Girl Scouts – Diamonds online donation page or Facebook fundraiser linked to [@girlscoutsdiamonds](https://www.facebook.com/girlscoutsdiamonds) to donate to a troop or service unit.
